*Honoring Choices<sup>®</sup> Florida, an advance care planning program of Community Hospice of Northeast Florida, encourages everyone, especially those with a diagnosis of a chronic or life-limiting illness, to have a conversation and document their wishes for future health needs.*

## **A CMS Benefit for Patient Choice and Quality of Life**

Recognizing the value of advance care planning (ACP) discussions, the Centers for Medicare and Medicaid Services (CMS) authorizes reimbursement for explanation and discussion of advance care planning by physicians, physician assistants, nurse practitioners, clinical nurse specialists and nurse midwives. In this context, ACP means the face-to-face discussion between the provider and the patient, helping the patient, family and decision makers understand medical options and plan for future health care. There is not a requirement that the conversation result in a written plan.

ACP conversation components include:

- Education about illness
- Identification of types of available treatments
- Decisions about care the patient would want if faced with a serious or life-limiting illness
- Identification of a medical decision maker in the event the patient loses capacity
- Importance of sharing wishes with family and other members of the care team

### **What are the reimbursement rates?**

While fiscal intermediaries may make slight adjustments to these rates regionally, the current reimbursement rates are as follows:

<b>CPT Code</b>	<b>Facility Payment</b>	<b>Non-Facility Payment</b>
99497 (First 30 mins)	\$79.54	\$85.99
99498 (Each additional 30 mins)	\$74.52	\$74.88

### **How should these CPT codes be used?**

These codes may be used in both facility and non-facility settings and are not limited to a particular physician specialty. Also, ACP services may be furnished “incident to” the services of the billing practitioner, and must include a minimum of direct supervision by the billing practitioner.

99498 cannot be used as a stand-alone code; 99497 must have been billed previously. There is currently no limit for the number of times 99498 may be used.

ACP services are subject to the normal 20% cost-sharing requirements unless furnished in conjunction with the Annual Wellness Visit (AWV), billed on the same day and on the same claim. If ACP services are provided at the time of the AWV, the new CPT codes should be used with modifier -33 so no Part B coinsurance or deductible will be charged.

## What are the requirements for reimbursement?

**Providers Approved to Bill:** Physicians, physician assistants, nurse practitioners, clinical nurse specialists and nurse midwives

**Time:** CMS follows CPT time rules for ACP; the provider must spend more than half of the time defined by the code face-to-face with the patient. That means at least 16 minutes of the 30 minutes indicated in each code descriptor (99497 & 99498).<sup>1</sup>

**Documentation:** To support a claim in the event of a denial, the provider's documentation should indicate the ACP conversation was separate from the AWV and include time spent on ACP.

Example: "In addition to the time spent conducting the AWV, I spent 20 minutes (from 3:25pm to 3:45pm) providing ACP services to patient, including discussion of ...".<sup>1</sup>
